TERMS AND CONDITIONS**

1. Information on how to claim and the gifts form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Claims are open to businesses operating in Australia that are Lawrence & Hanson, EWS or Auslec credit account holders (each an “Eligible Business”), excluding directors, management, employees and their immediate families of the Promoter and its related bodies corporate and agencies associated with this promotion. Immediate family means any of the following: spouse, ex-spouse, defacto spouse, child or step-child (whether natural or by adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister or 1st cousin.

5. In all instances, gifts will be awarded to the manager or owner of the Eligible Business who may, in his/her absolute discretion, allocate the gift to any employee (aged 18 years or over) of that Eligible Business (the “**Gift Recipient**”).
6. There is one (1) type of gift available for redemption in accordance with clause 7 being: (a) one (1) (“**Gift 1**”) of random points that will be automatically loaded to the customer’s account
7. To be eligible for Gift 1, Eligible Businesses must, during the Promotional Period, spend a total of \$200,00 or more (excluding GST) on any participating Sparky Plus Supplier partners via the LAWRENCE & HANSON branch or LAWRENCE & HANSON **eBranch** Application or online at <https://www.lhgnow.com.au/>, via their LAWRENCE & HANSON account (“**Gift 1 Qualifying Spend**”). For clarity, only orders that are invoiced will be eligible for the purposes of this promotion. Orders must be placed and invoiced during the Promotional Period. Gift 1 Qualifying Spend does not need to be made in a single transaction on products during the Promotional Period.
8. Every Eligible Business that successfully makes a Gift 1 Qualifying Spend during the Promotional Period will be awarded Gift 1. The Scratch & Win card will be provided by the branch at the time of invoice.
9. Only one per account holder and one business owner is eligible for (1) unique barcode to be entered via Sparky Plus Platform. Business owners with more than one account number will be removed from the qualification unless the promotor deems otherwise and the qualification has been met more than once.

10. How this Scratch & Win promotion works is any customer who spends over \$200 ex gst in one transaction is provided with a Scratch & Win Card . The Scratch & Win Card has a code that is individual and unique. The customer just needs to log into the sparky plus.com.au platform and as you can see from the login sparkyplus.com.au they just enter the code to see if they have won a stake in the 700'000 points up for grabs randomly allocate to unique codes.

Customers who don't win anything with the entered code are automatically entered into the second chance draw with a range of 25 products up for grabs.

General

Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
